CAMPAIGN CONTEST - RULES

ELIGIBILITY

1. The *Ontario Society of Professional Engineers 'Change the World' Social Media Contest* ("**Contest**") is open to persons who reside within the Province of Ontario; are eligible for an OSPE membership (meet the requirements for membership within the Student, New Graduate, Intern New Graduate, Intern Member, Associate Member, Professional Member or Professional 65+ Member categories as outlined on the OSPE website and in the OSPE Bylaws); are a registered member of the Venngo MemberPerks program; and reached the age of majority in the Province of Ontario as of the date of entry for the Contest with the following exceptions: employees and retirees of OSPE and its affiliates, representatives, agents, franchisees, dealers and advertising and promotional agencies, and the household members and/or immediate family of any of the above are not eligible to participate in the Contest ("**Entrants**"). For the purpose of these Contest Rules, "immediate family" means spouse, mother, father, brother, sister, son or daughter, whether or not they reside in the same household. If your Venngo MemberPerks program membership is cancelled or expires during the term of this contest, you will not be eligible for this contest.

LIABILITY

1. OSPE, Venngo and their associates, directors, officers, employees, agents, representatives, successors, contest sponsor, their parent companies, subsidiaries, affiliates and related companies and each of their respective officers, directors, employees and agents are not responsible for injury or damage to participants' or any other person's computer or mobile device related to or resulting from participation in the contest including viewing, playing or downloading materials from Venngo sites, apps or social media.

OSPE and Venngo reserves the right, in its sole discretion, subject to the approval of the RACJ, to cancel, suspend or modify this contest should a virus, bug or any other cause beyond the reasonable control of OSPE and/or Venngo corrupt the security or proper administration of the contest. Any attempt to deliberately damage any web site or to undermine the legitimate operation of this promotion is a violation of criminal and civil laws, and should such an attempt be made, OSPE and Venngo reserves the right to seek remedies and damages to the fullest extent permitted by law - including criminal prosecution.

HOW TO ENTER

2. No purchase necessary. To enter the Contest, Entrants must follow the directions outlined in a given biweekly social media post shared by OSPE on one of its official social media channels (Facebook, LinkedIn, Twitter or Instagram) during a specified "**Giveaway Period**". The thirteen (13) giveaway periods are listed below under "Prize Winner Selection". To qualify for a prize, Entrants will be required to complete a specified task, such as, but not limited to, commenting on a post, tagging a friend, sharing a post, or liking a post on the appropriate social media channel. Maximum or minimum entries do not apply—the required task must simply be completed within the appropriate Giveaway Period to qualify. Each of the thirteen (13) social media Giveaway Periods and associated prizes are independent of all others.
3. All entries for the biweekly prize giveaways must be received by OSPE during one of the thirteen (13) specified Giveaway Periods. The first giveaway will begin when the first set of instructions are posted on social media on September 8, 2017 ("**Contest Opening Date**") and the last giveaway will end at 11:59:59 p.m. EST on May 1, 2018 ("**Contest Closing Date**").
4. All entries will be automatically entered into the Contest for the duration of the Contest.
5. Entries that are incomplete, late, lost, misdirected and/or irregular in any way or sent by an unauthorized method are automatically void and will not be eligible or accepted. Entries will only be accepted as described herein and will not be accepted by any other means.
6. Posting a large number of duplicate, or near duplicate, social media postings will be considered a violation of contest rules and will lead to postings being ineligible for the contest.
7. Postings must not violate rules of the social network in which they are posted.
8. Anyone found using multiple accounts within a single social network to participate in the contest will be disqualified.
9. Any submissions deemed by Venngo to be inappropriate or not suitable will be disqualified at the sole discretion of Venngo.
10. By entering the Contest, Entrants agree to be bound by these Contest Rules.

THE PRIZES

1. Thirteen (13) Prizes (each a "**Prize**", collectively the "**Prizes**") are available to be won. One (1) Prize will be awarded bi-weekly. Each draw will consist of a pre-designated Prize such as, but not limited to restaurant gift cards or movie theatre packages, each worth approximately \$50.
2. Limit of one Prize per Entrant.

THE PRIZE MUST BE ACCEPTED AS AWARDED, AND MAY NOT BE ASSIGNED, TRANSFERRED, SUBSTITUTED EXCHANGED, REFUNDED OR REDEEMED FOR CASH VALUE. PRIZE WINNER CONFIRMATION

2. Selected Entrants will be notified via direct message on the same social media platform on which he/she participated in a given Giveaway Period. No communication or correspondence will be entered into, except with selected Entrants. OSPE Venngo are not responsible for changes to the email address, mailing address and/or telephone number of the Entrant.
3. To be confirmed a Prize winner, the selected Entrant must:
 - (a) confirm compliance with these Contest Rules;
 - (b) accept the Prize as awarded;
 - (c) sign and return a Declaration of Eligibility and Release, in the form requested by OSPE, within ten (10) business days from the date of delivery thereof.

Entries are subject to verification and will be declared invalid if they are illegible, mechanically reproduced, mutilated, forged, falsified, altered or tampered with in any way. OSPE reserves the right to change the terms of this Contest or terminate it at any time, without prior notice.
